## **EFFECTIVE JANUARY 1, 2018**

The following mandatory taxes will be applied to all purchases:

<b>*San Diego Excise Tax</b>	<b>5%</b>
<b>*California Sale Tax</b>	<b>7.75%</b>
<b>**California Excise Tax</b>	<b>15%</b>

**\*A customer with a California Medical Marijuana Identification Card (MMIC) will not be charged the 5% San Diego Tax or the 7.75% California Sales Tax on product containing cannabis. Your local doctor's recommendation does NOT qualify as a State issued MMIC. You can obtain a MMIC at your Local County Public Health Dept, not through your physician or an evaluation center.
